

AGREEMENT FOR THE DEVELOPMENT OF RURAL ROADS PROJECTS – CENTRAL DIVISION

This agreement is entered into on the 2nd day of February 2016

BY AND BETWEEN: THE MINISTRY OF RURAL AND MARITIME DEVELOPMENT AND NATIONAL DISASTER MANAGEMENT

AND: THE MINISTRY OF LANDS AND MINERAL RESOURCES

AND: THE MINISTRY OF LOCAL GOVERNMENT, HOUSING AND ENVIRONMENT

AND: **FIJI ROADS AUTHORITY**, a corporate body established under section 4 of the Fiji Roads Authority Decree 2012, having its office at Level 4, Fiji Development Bank, 360 Victoria Parade Suva, Fiji

(Collectively referred to as Parties)

THE PARTIES AGREE AS FOLLOWS:

WHEREAS the Commissioner Central's Office of the Ministry of Rural and Maritime Development and National Disaster Management ('**Ministry**') and Fiji Roads Authority met on 11 September 2015 at the Fiji Roads Authority Office and agreed to draw up a list of projects for the completion of the ongoing road upgrading works and for new projects for 2016, 2017 and 2018;

AND the Parties intend to ensure that the projects identified below are completed in accordance with the identified timelines.


GRAVEL LICENCE AND LAND ACQUISITION

- 3.0 Any revisions or amendments to this Agreement which are mutually agreed upon by the Parties to this Agreement shall be incorporated by written agreement, and effective when executed and signed by Parties.


