If the site has been rezoned, then provide rezoning plan with conditions of approval.</p> <p>e) Road Reserve: State the Width of Road being proposed/existing</p> <ul style="list-style-type: none"> • 9m accepted at present will increase to a min of 12m in <i>residential areas</i> • 16m in <i>industrial</i> and feeder roads • 20m for arterials <p>f) Drainage: Show Drainage Provisions (in relation to road).
